## H. BUSINESS SERVICES – ACTION/DISCUSSION ITEMS

1. <u>10 Year Enrollment History and 6 Year Enrollment Projection from School Years</u> 2022/23 to 2028/29.

Assistant Superintendent Robert Whittenberg stated that every year, after CBEDS enrollments are compiled, new enrollment projections are calculated based on the most current data available.

The District contracts with SchoolWorks, Inc. to prepare a Demographic Study that provides a one-year projection detail by grade level and school, and a 10-year projection summary by school with 10 years of historical data. These projections are used to determine staffing and facility needs and are based on current school boundaries and attendance patterns using trend analysis of the students moving from grade to grade, new housing development rates and yield factors applied to historical trends, and Intra-District transfer analysis.

Mr. Ken Reynolds from SchoolWorks, Inc. provided a detailed overview of the District's EDUHSD Demographic Study.

## 2. Oak Ridge High School Drop-Off Zone & Facilities Update.

Mr. Dan Augino stated that the traffic congestion at Oak Ridge High School has been a source of frustration for students, staff and the surrounding community members for several years. In early 2022, he enlisted the help of our El Dorado County Department of Transportation Engineers and Traffic Experts, along with our District Architect, California Design West, to view and discuss the traffic problems, as well as the most efficient use of the high school property.

During the past year, District Staff, California Design West and the County DOT engineers studied the traffic patterns and completed a drone survey of the area to clearly identify the main source of traffic and congestion.

## The four main issues are:

- 1. Heavy pedestrian traffic in front of the school crossing at the four-way stop sign crossing at Harvard Way and Clermont Way and the school Front Parking Lot exit.
- 2. Congestion caused by students being dropped off and picked up on the street, in the parking lots and in front of the school.
- 3. Competing interests in parking spaces and through traffic in and out of the school parking lots impacting students, staff and community visitors.
- 4. Inefficient use of school property. The outdated design was built to accommodate 8 school buses in the loading zone when only 2 buses are current used.

The Design Team developed three improvement plan options and shared them with site staff and District Administrators. The option being presented tonight was unanimously chosen as the best option. The main features of the improvements are listed below.

- 1. A traffic control signal light for pedestrians and vehicles in front of the school at Harvard Way and Clermont Way.
- 2. Redesign the front parking lot to increase parking spaces and provide two lanes for student drop off and pick up and one lane for bypassing the drop-off zone to access both parking lots.
- 3. Join the student parking lot with the front parking lot with a roundabout intersection.
- 4. Provide an entrance/exit from the east parking lot onto Silva Valley Parkway at the south end of the parking lot.
- 5. Relocate the student bus loading zone to the current lawn area in front of the west parking lot.

## 3. Second Interim Budget Report.

Assistant Superintendent Robert Whittenberg reported about the changes to the budget from the first interim to the second interim report for 2022/23. He stated that updated budget and subsequent year projections to reflect the ongoing implementation of the Local Control Funding Formula (LCFF), the formula rolled the revenue limit and numerous grants into one funding model. Based on the California State Adopted 2022/23 budget and other projections. He reviewed the District's revenue, enrollment, other factors, expenditures, and reserves.

Assistant Superintendent Robert Whittenberg stated that the District currently has sufficient projected resources and reserves to maintain a positive fund balance through the end of the 2024/25 fiscal year. The District will continue to review programs and expenditures in order to maintain fiscal viability in the future.

## 4. Resolution 2022/23-17 Committed Funds.

Assistant Superintendent Robert Whittenberg reported that school district governing boards are responsible for maintaining the fiscal solvency of the schools they govern. The

purpose of creating the committed fund balance in GASB 54 is to improve fiscal reporting through fund balance categories that will be more easily understood. The conditions required to activate the local reserve cap were met in 2021-22, which means the cap will go into effect beginning with the 2022-23 fiscal year.

5. <u>Public Hearing and Approval for a Student Transportation Plan for the 2022-23 School</u> Year.

In order to receive the funds, the District is required to adopt a Student Transportation Plan annually on or before April 1, 2023.

Mrs. Rodgers opened the meeting to a public hearing to solicit the recommendations and comments of members of the public regarding the proposed Student Transportation Plan which was posted on the EDUHSD website and made available for comment via **Zoom**. There being no comments, Mrs. Rodgers closed the public hearing.

## I. STUDENT SERVICES – ACTION/DISCUSSION ITEMS

1. <u>Legal Counsel, Ongoing Litigation, subject to Government Code section 54956.9, regarding proposed settlement of claims related to e-cigarettes and vaping issues.</u>

Senior Director Chuck Palmer stated that the El Dorado Union High School District sued JUUL Labs, Inc., and others, for damages suffered by the district resulting from the youth vaping epidemic. El Dorado Union High School District alleged that JUUL Labs' design, manufacture, production, advertisement, marketing, distribution, and sale of its JUUL e-cigarette products overtly and purposely targeted kids, leading to substantial increase in youth use of vaping and e-cigarette devices, which required El Dorado Union High School District to expend money and resources on addressing student use on campuses. The proposed settlement heard in closed session resolves the claims against JUUL Labs, Inc. and its agents. Litigation against other named defendants will continue.

2. <u>Consideration of Student Disciplinary Matters Relating to Expulsion and/or Readmission</u>. (GC 54954.5[h]; EC 35146, 48918[c])

The Board of Trustees hereby adopts the Expulsion Agreement, Rehabilitation Plan and Order of the Board of Trustees regarding the stipulated expulsion of Students #22-8 and #22-9.

## J. HUMAN RESOURCES – ACTION/DISCUSSION ITEMS

1. <u>Disclosure and Ratification of the Master Contract between the El Dorado Union High School District and the Faculty Association for 2022-2023.</u>

Assistant Superintendent Tony DeVille reported that AB1200 and Government Code section 3547.5 required local education agencies to publicly disclose the provisions of all collective bargaining agreement before the Board gives final approval to the Agreement. The Disclosure Statement is attached and has been posted on the District bulletin board for public review.

The Board of Trustees and the District Administration have been engaged in contract negations with the Faculty Association and on Thursday, January 26, 2023, signed a Tentative Agreement. Subsequently, the Faculty Association Board notified the District that the membership approved the Tentative Agreement, and it is now being presented for final approval to the Board of Trustees.

2. <u>Approval of Application for a Provisional Internship Permit for Thomas Fennell, Mathematics Teacher at Union Mine High School.</u>

Assistant Superintendent Tony DeVille reported that the Administration is requesting approval to submit an application for a Provisional Internship Permit (PIP). This PIP will allow for the hiring of a full-time, Mathematics teacher at Union Mine High School. Multiple recruitments for a mid-year replacement Mathematics teacher resulted in few applicants with appropriate qualifications. This PIP will permit the teacher, Thomas Fennell, to continue to work for the remainder of the 2022-2023 school year. The assignment is three periods of Mathematics (grades 9 12).

Mr. Fennell has a degree in Engineering and thus a background in Mathematics. He is currently enrolled in a credentialing program with National University, has passed the

CBEST examination and holds a 30day substitute credential. He has worked as a long-term substitute in multiple classrooms within the District.
