2. <u>Legal Counsel, Ongoing Litigation, subject to Government Code section 54956.9, regarding proposed settlement of claims related to e-cigarettes and vaping issues.</u>

Senior Director Chuck Palmer reported that the El Dorado Union High School District sued Altria Inc., parent company of JUUL Labs, Inc., and others, for damages suffered by the district resulting from the youth vaping epidemic. El Dorado Union High School District alleged that Altria's design, manufacture, production, advertisement, marketing, distribution, and sale of its products overtly and purposely targeted kids, leading to substantial increase in youth use of vaping and e-cigarette devices, which required El Dorado Union High School District to expend money and resources on addressing student use on campuses. The proposed settlement heard in closed session resolves the claims against Altria Inc. and its agents.
