F. EDUCATIONAL SERVICES – ACTION/DISCUSSION ITEMS

1. <u>Approval of Proposed New Instructional Materials Recommended for Adoption for</u> the 2023-24 School Year.

Deputy Superintendent Christopher Moore reported that each year, the El Dorado Union High School District adopts instructional materials for new courses and classes which have revised their courses of study in accordance with the adoption cycle. Instructional materials in each curricular area are aligned with District and California content standards.

For the 2023-2024 school year, Biology and AP Physics instructional materials are being recommended for adoption. Staff from all sites, as well as parent representatives participated in the evaluation of instructional materials, and a consensus or a majority vote was used to select a common instructional material for this District course. The SILT Coordinating Chair is commended for their excellent organization and management of this selection process.

Recommended material purchases for the 2023-2024 school year:

- AP Physics, College Physics by Cengage, Copyright 2018, ISBN: 9781305965393

2. <u>Earth and Space Science D Approved UC Lab Science Course.</u>

Mr. Moore reported that the Earth and Space Science course is designed in accordance with the Next Generation Science Standards. During the WASC accreditation process for Oak Ridge High School, the District policy of not granting

at grade level ninth grade students access to a University of California (UC) "D" approved lab science course was questioned.

The WASC visiting team highlighted that we might be the only educational agency in the state that restricts at grade level students in the 9th grade from taking lab science courses. Other districts in the state have received UC approval for Earth and Space Science as a D level lab course, and the course is listed as a qualifying course on the UC admissions portal. Upon recommendation from the science departments within our district, we propose submitting Earth and Space Science for D level approval from UC and transforming the course from a G approved UC elective to a D approved science course. This change will enhance our students' college applications and potentially increase their college attendance rates.

Mrs. Van Komen moved to approve the Earth and Space Science Course of study as a D approved UC lab science course. Mrs. Veerkamp seconded. Motion carried (4-0).

3. <u>California Dashboard Local Indicators.</u>

Mr. Moore reported that the State Board of Education (SBE) approved standards for the local indicators that support local educational agencies (LEAs) in measuring and reporting their progress within the appropriate priority area. For each local indicator, the performance standards are as follows:

- 1. Annually measure its progress in meeting the requirements of the specific LCFF priority; and
- 2. Report the results as part of a non-consent item at a regularly scheduled public meeting of the local governing board/body in conjunction with the adoption of the LCAP; and
- 3. Report results to the public through the Dashboard utilizing the SBE-adopted self-reflection tools for each local indicator.

The Administration recommends that the Board of Trustees receive the annual California Dashboard Local Indicator report that is supported by the District's adopted LCAP.

4. <u>El Dorado Union High School District Local Control and Accountability Plan</u>
(LCAP) Public Hearing to Solicit Recommendations and Comments of Members of the Public.

Mr. Moore reported that the LCAP is intended as a comprehensive planning tool to support student outcomes and is an important component of the local control funding formula (LCFF). Under the LCFF, all local educational agencies (LEAs) including school districts, county offices of education (COEs), and charter schools are required to prepare an LCAP, which describes how they intend to meet annual goals for all pupils, with specific activities to address state and local priorities. The Board shall hold at least one public hearing to solicit the recommendations and comments of

members of the public regarding the specific actions and expenditures proposed to be included in the LCAP. The public hearing shall be held at the same meeting as the budget hearing. The Board shall adopt the LCAP prior to adopting the District budget, but at the same public meeting. This meeting shall be held after the public hearing described above, but not on the same day as the hearing.

Under the LCFF, all local educational agencies (LEAs) including school districts, county offices of education (COEs), and charter schools are required to prepare an LCAP, which describes how they intend to meet annual goals for all pupils, with specific activities to address state and local priorities. Assistant Superintendent Robert Whittenberg advised that the Education Code requires that school districts hold a public hearing to receive and consider public comments regarding the 2023/24 Proposed Budget.

Mr. Whittenberg reported that each year in mid-May, the Governor produces a revision to the state's proposed budget issued in January. Education Code § 42127(a) (2) requires that school districts adopt an annual budget no later than July 1 of each year. Mr. Whittenberg presented, for review and discussion, the May Revise budget information and the first draft of the District's completed budget based on the May revision.

Mrs. Rodgers opened the meeting to a public hearing. There being no comments, Mrs. Rodgers closed the public hearing.

Board accepts for consideration the information provided concerning the 2023-24 Proposed Budget.

2. Resolution 2022/23-21 Committed Funds.

Mr. Whittenberg reported that school district governing boards are responsible for maintaining the fiscal solvency of the schools they govern. The purpose of creating the committed fund balance in GASB 54 is to improve fiscal reporting through fund balance categories that will be more easily understood. The conditions required to activate the local reserve cap were met in 2021-22, which means the cap will go into effect beginning with the 2022-23 fiscal year.

I. HUMAN RESOURCES – ACTION/DISCUSSION ITEMS

1. <u>Approval of Application for a Provisional Internship Permit for Chelsey Collins, Art Teacher at Union Mine High School.</u>

Assistant Superintendent Tony DeVille commented that the Administration is requesting approval to submit an application for a Provisional Internship Permit (PIP). This PIP will allow for the hiring of a full-time, Art teacher at Union Mine High School. The recruitment for multiple Art teachers resulted in few applicants with appropriate qualifications. This PIP will permit the teacher, Chelsey Collins, to work for the 2023-2024 school year while she is completing coursework towards her credential which will make her internship eligible. The assignment is six periods of Art (grades 9-12) on the 4x4 block schedule. Ms. Collins has a degree in Applied Studies

with significant coursework in Art. She is currently enrolled in a single subject credentialing program with University of Massachusetts Global and has passed the CBEST examination. She has worked as a classified employee within the District for the last several years.

Mrs. Veerkamp moved to approve submittal of the Provisional Internship Permit to the CTC on behalf of Chelsey Collins. Mrs. Van Komen seconded. The motion unanimously carried (4-0).
