Approval of Courses of Study for the 2023-2024 School Year.

Deputy Superintendent Christopher Moore reported that the Governing Board recognizes that a well-aligned sequence of courses fosters academic progress and provides for the best possible use of instructional time. The District's courses of study provide students with opportunities to attain the skills, knowledge, and abilities they need to be successful in school, college, and the workplace. 2. <u>Approval of Proposed New Instructional Materials Recommended for Adoption for the 2023-2024 School Year.</u>

Deputy Superintendent Christopher Moore reported that each year, the El Dorado Union High School District adopts instructional materials for new courses and classes which have revised their courses of study in accordance with the adoption cycle. Instructional materials in each curricular area are aligned with District and California content standards.

For the 2023-2024 school year, Japanese 1-4, Spanish Heritage 1 and 2, and AP US History instructional materials are being recommended for adoption. Staff from all sites, as well as parent representatives participated in the evaluation of instructional materials, and a consensus or a majority vote was used to select a common instructional material for this District course.
