Superintendent Carruth thanked everyone for being at the meeting tonight and shared that there will be some great recognitions. It is also a very special night as we have the opportunity to introduce the District's new Superintendent, Mike Kuhlman, effective July 1, 2024. It is a wonderful time to celebrate together as a school community.

C. SUPERINTENDENT EMPLOYMENT CONTRACT

1. Approval of Superintendent Employment Agreement.

Board President Carry stated that with this agenda item the F

Board President Cary stated that with this agenda item the Board is considering the approval of an employment agreement setting forth the terms and conditions for employing **Michael ("Mike") Kuhlman** as the District's Superintendent starting July 1, 2024, following the retirement of Ron Carruth.

Prior to taking final action, Government Code section 54953 requires the Board to provide an oral summary of the recommendation for approval on the salaries, salary schedules, or compensation paid in the form of fringe benefits of a local agency executive during the open meeting in which the final action is to be taken.

Accordingly, Board President Cary provided an oral summary of the financial terms of the Superintendent's employment agreement being considered by the Board this evening:

- The Agreement will have a 3-year term beginning July 1, 2024.
- Mr. Kuhlman will be required to work 221 full and regular service days to the District each year of the Agreement, and in year 1 he will be placed on Step 5 of the Superintendent Salary Schedule at an annual Base Salary rate of \$319,272.
- The Board will approve a salary schedule for the Superintendent, and in accordance with the Superintendent Salary Schedule his Base Salary will be automatically increased annually by 2%, dependent upon receiving a satisfactory performance evaluation each year.
- The Superintendent will be entitled to (1) working day of sick leave each month and District-paid family health and welfare benefits.
- The District will pay the Superintendent's membership fees for membership in professional organizations up to a maximum of \$4,000 annually, and he will be reimbursed for expenses to attend appropriate professional meetings at the community, local, state and national level, and for actual, necessary, and reasonable expenses, that

are incurred within the scope of the Superintendent's employment, including mileage for travel outside of El Dorado County for District business at the current IRS mileage reimbursement rate.

• Mr. Kuhlman will also be provided with technology devices needed to facilitate his performance of his duties and obligations to the District.

I. BUSINESS SERVICES – ACTION/DISCUSSION ITEMS

1. Continuation of CalSHAPE HVAC Project.

Assistant Superintendent Whittenberg shared that the initial phase of the CalSHAPE project has been successfully completed, encompassing crucial tasks such as the installation of new filters across all HVAC units, integration of CO2 monitors in every classroom, comprehensive testing, and balancing of all units, alongside various maintenance and repair initiatives. The Veregy proposal is for the continuation of the CalSHAPE HVAC Project into Phase 2, in accordance with the specifications outlined in the original Request for Proposal (RFP) document (CalSHAPE Program Services RFP#3-2223) and the accompanying addendum.

Phase 2 aims to leverage the data gathered during the initial phase to identify HVAC units eligible for major upgrades or complete replacement. Additionally, this phase encompasses provisions for electrical enhancements, building management system improvements, and any other related endeavors deemed necessary.

2. Oak Ridge High School Silva Valley Parkway Entrance Award of Bid.

Assistant Superintendent Whittenberg shared that on March 12, 2024 the Board approved going out to bid for the Silva Valley Access Road Project at Oak Ridge High School. Bid Advertisements went out March 18th and 25th of 2024. The mandatory job walk was on March 26th, 2024. Seven contractors attended the mandatory job walk. Of those seven contractors, five prequalified per the Prequalification Specifications. Bid opening was on March 12th, 2024 at 3:00 p.m.

Three contractors submitted bids and Western Engineering Contractors, Inc. was the lowest bid at \$1,993,000.00.

The Project will be started as soon as possible with a goal of completion in September of 2024.

Based on student and community feedback, data, and the clear needs stemming from the pandemic, EDUHSD Counselors have invested a tremendous amount of effort into improving practices based on a Multi-Tiered System of Support (MTSS) model in the areas of Academic, Career, and Social Emotional Counseling. Their efforts are yielding improved outcomes for students and have increased tremendously the availability of School Counselors for students. Our School Counselors are truly "Lighthouses" for our students, guiding them to a promising future and acting as a beacon of hope in the often rough seas of adolescence.
