2. Disclosure and Ratification of the Master Contract Between the El Dorado Union High School District and the Faculty Association for 2023-2024. Assistant Superintendent Robert Whittenberg stated that AB1200 and Government Code section 3547.5 required local education agencies to publicly disclose the provisions of all collective bargaining agreements before the Board gives final approval to the Agreement. The Disclosure Statement is attached and has been posted on the District bulletin board for public review.

The Board of Trustees and the District Administration have been engaged in contract negotiations with the Faculty Association and on Monday, January 29, 2024, signed a Tentative Agreement which includes a 5.9% COLA increase and 0.10% new hire benefits increase retroactive to July 1, 2023. Subsequently, the Faculty Association notified the District that the membership approved the Tentative Agreement, and it is now being presented for final approval to the Board of Trustees.

1. Local Control Accountability Plan (LCAP) Mid-Year Monitoring Report. Pursuant to Section 61 of Ed Code 52062, as Amended by SB 114:

Assistant Superintendent Leslie Redkey stated that the LEA shall present a report on the annual update to the LCAP and the LCFF Budget Overview for Parents on or before February 28 of each year at a regularly scheduled meeting of the governing board of the school district. The report shall include both of the following: All available midyear outcome data related to metrics identified in the current year's local control and accountability plan and all available midyear expenditure and implementation data on all actions identified in the current year's local control and accountability plan.

#### I. BUSINESS SERVICES – ACTION/DISCUSSION ITEMS

1. <u>10 Year Enrollment History and 6 year Enrollment Projection from School Years</u> 2023-24 to 2029-30.

Assistant Superintendent Robert Whittenberg stated that every year, after CBEDS enrollments are compiled, new enrollment projections are calculated based on the most current data available. SchoolWorks, Inc. has prepared a Demographic Study for the 10 Year Enrollment History and 6 Year Enrollment Projection. The study provides a one-year projection detail by grade level and school, and a 10-year projection summary by school with 10 years of historical data. These projections are used to determine staffing and facility needs and are based on current school boundaries and attendance patterns using trend analysis of the students moving from grade to grade, new housing development rates and yield factors applied to historical trends, and Intra-District transfer analysis. SchoolWorks will present the study to the Board.

Mr. Ryan Reynolds from SchoolWorks, Inc. provided a detailed overview of the District's EDUHSD Demographic Study.
